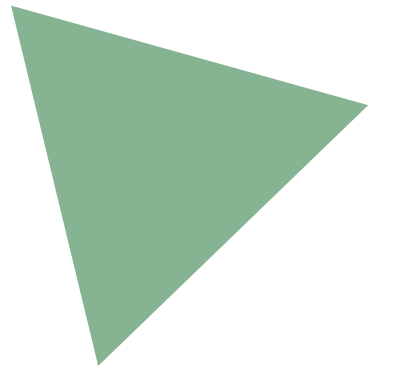

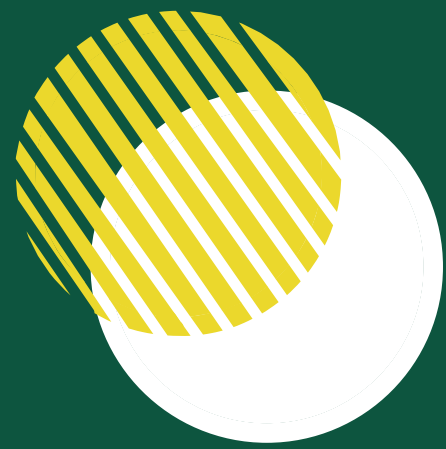

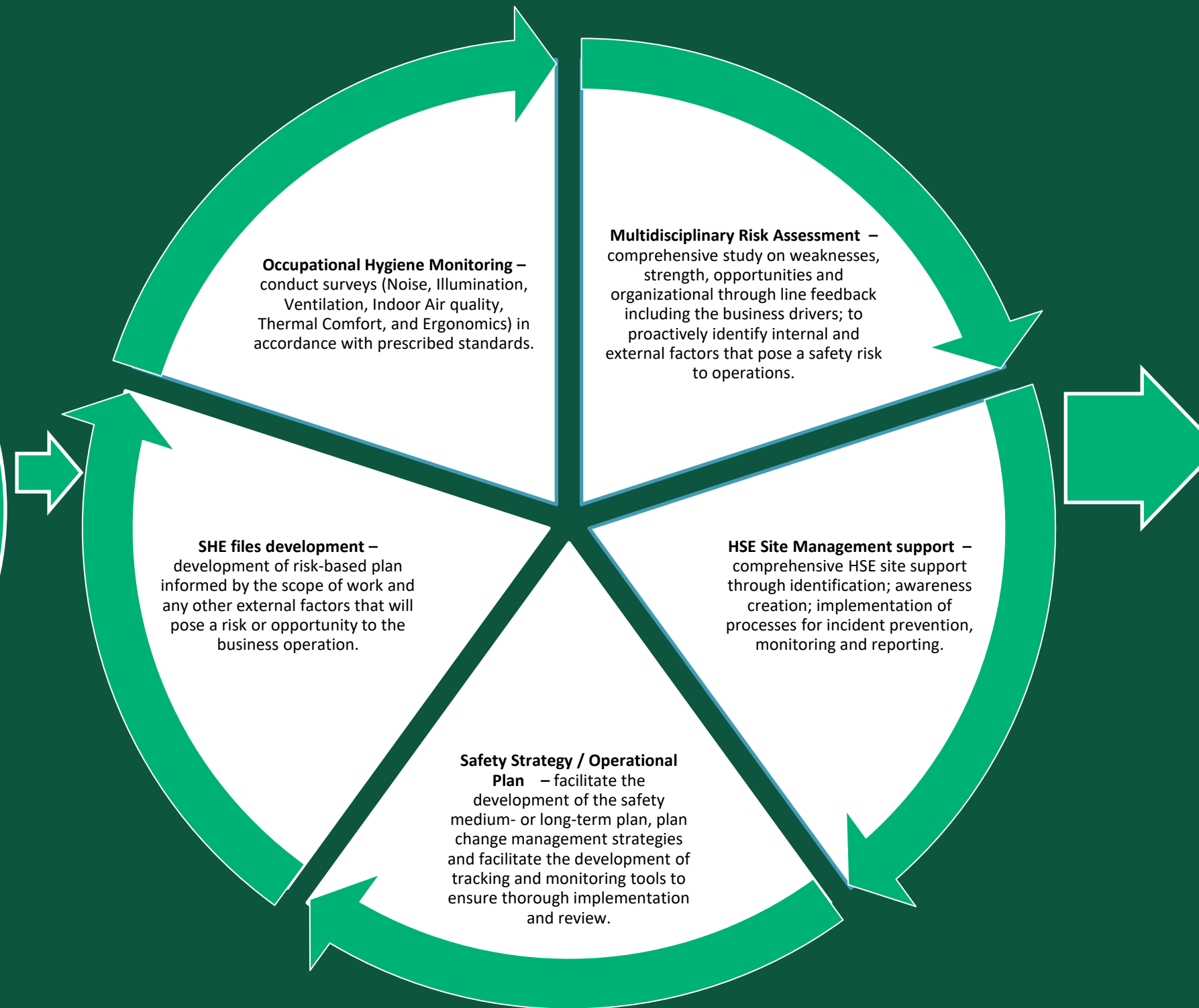




# Occupational Safety Management Services

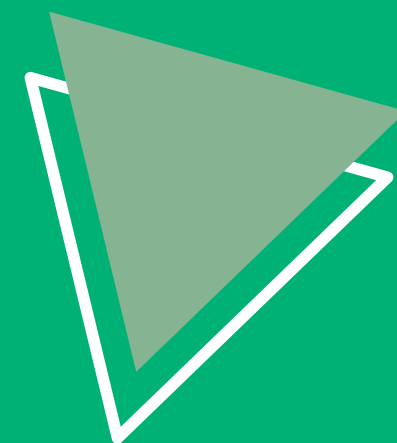

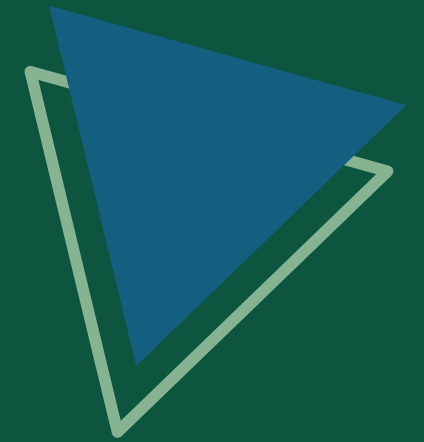
